A Parish Council : what's it for?

A Parish Council exists "To provide services for, manage and maintain the assets of the villages, with the resources provided by the annual precept and other incomes, taking into account the wishes of the residents and obtaining value for money". [National Association of Local Councils]

But in plain speak:



Your Parish Councillors are your neighbours and we live in the community we represent. Our role is to talk to you and find out what your priorities are.

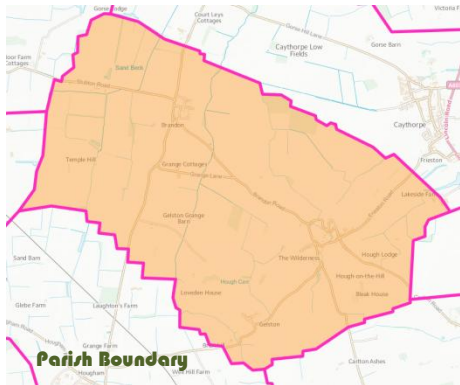


The Parish Council raises money from the 'precept', collected with Council Tax; currently it is around 21p (yes pence) per person per week. Income can also come from grants or charges for services and of course donations. Unlike other taxes though – it all gets spent here in our Parish.



We need to ensure the 'assets' owned by the Parish are looked after for the benefit of everyone; such as the play and recreation area in Hough (top right), the village green in Gelston (right) and the open space by Brandon church (below right).

Roger Kingscott – Chairman

Paul Miley – Councillor
Paul moved to Brandon to restore a property in 2000. Active as a community first responder, he took up a vacant seat in 2014.

Your PC's Powers:

The Parish Council is a legal entity with powers granted by Parliament; it has a **duty** to appoint a Chair, have audited accounts, hold at least 4 meetings a year and operate to a code of conduct. Anyone can attend the meetings to observe and raise questions.

The **powers** (from various acts of Parliament) are wide ranging and not always what you expect:

- Environment
- Allotments
- Markets
- Planning
- Ponds
- Tourism
- Cemeteries
- By-Laws
- Clocks
- Highways
- Community Centres
- Arts
- Public WCs
- Webistes
- Commons
- Crime Prevention
- Bus shelters

More detail on **Planning** is in this issue; but consider that amongst the 9000 English local councils, there are some:

- Running community transport
- Organising festivals
- Providing equipment for activity groups
- Operating local services such as a shop
- Clearing common ground
- Employing a handyman for the benefit of residents

You get the picture; your PC has a great deal of freedom to implement activity for the benefit of those living in the area. But of course most things require people and/or additional costs. So before we do anything, we need to hear your views.

The request for contact details is to allow us to hear from you.

Your Parish Clerk:

The Clerk is employed by the Council and is the officer concerned with much of the work between meetings. As an employee, the Clerk therefore need not seek election.

Where does the money go?

The Precept is equivalent to around 21p per week for each person living in the Parish and amounts to around £5500 annually. It is absorbed by:

- Insurance - £550**
- Accountants - £150
- Grass Cutting - £2000**
- Playing Field - £500**
- Hall Hire (for meetings) - £100
- Clerk's Wages - £1700**
- Expenses & Printing - £450
- Memberships - £150

All Councillors volunteer their time and take no expenses from the Precept.

Neighbourhood Plan

You may well have been involved in preparing our Hough on the Hill Parish Neighbourhood Plan over the last two years.

If you were, thank you.

The plan was submitted to SKDC in Autumn 2014 and has now been approved by an independent inspector. The next step is for SKDC to organise a local referendum, but this seems to have been held up by the forthcoming national and district council elections. As soon as the date is announced we will let everyone know.

However even now, if you are planning a development within the Parish, please consult the document to be found at www.loveden.org.uk/np and ensure your proposals meet the requirements.

Planning Matters

The Planning Authority (SKDC) must consider the Parish view before deciding to approve or reject an application. Your PC will always consider the interests of local residents, including the applicant, but decisions must be based on:

- SKDC's Local Development Plan
- Our own Neighbourhood Plan
- Material Considerations

We are not planning experts, but we may be able to advise on what is (and isn't) a viable idea and also what constitutes a valid objection.



Hot Topics

Over the last year the Parish Council has tackled a wide range of topics. Some are completed, but we would welcome your input on other issues, to prioritise and guide the next stages. This newsletter gives lots of ways to get in touch:

- Completion and submission of the Neighbourhood Plan
- Road safety and speed monitoring through the villages
- Improved facilities for the Hough recreation ground
- Numerous planning applications including wind farms
- Potential use for the Parish land in Brandon
- Improving Parish notice boards
- Car parking at Brandon on Hough Lane
- Footpath up keep
- Railway crossing closures
- Police liaison
- Preserving Gelston Green
- Improved communications
- Retention and adoption of the red telephone boxes in Brandon and Gelston (for potential defibrillator installation)
- Ongoing support for the Hough community defibrillator

- Come along to any Council meeting (there is a public forum at the start)
- Raise it at the Annual Parish Meeting (see below).

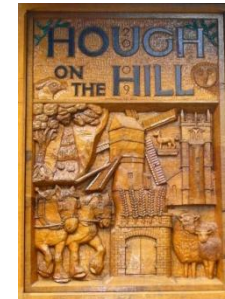
Should we invest to improve the standard?
